



## Frequently asked questions

### **What are the Australian Crime and Violence Prevention Awards?**

The annual Australian Crime and Violence Prevention Awards (ACVPA) are a joint Australian Government, state and territory initiative administered by the Australian Institute of Criminology (AIC).

The awards are designed to recognise good practice in the prevention and reduction of violence and other types of crime in Australia, to encourage public initiatives to prevent crime and to assist governments in identifying and developing practical projects that will reduce violence and other types of crime in the community.

Winners will be presented with a commemorative plaque and/or a certificate at a national awards ceremony at Parliament House, Canberra. Monetary awards may also be granted at the discretion of the ACVPA Board. Winners will be invited to record video footage of their project and may be offered financial assistance to help with travel costs to attend the award ceremony in Canberra. Generally speaking, projects that are led by government agencies or are substantially supported by government funds are not eligible to receive cash awards.

### **Who can enter?**

Nominations are open to projects of all sizes, including smaller initiatives involving local community groups. The project must have been fully operational prior to 1 February 2023 to be eligible for the 2024 awards.

Anyone can nominate a project for the awards. It may be a project you are involved in, or a project that you believe deserves recognition.

The awards are designed to reward benchmark projects, as well as projects which exhibit good practice in the prevention or reduction of violence and other types of crime in Australia.

### **Who is not eligible to apply for an award?**

Projects that commenced after 1 February 2023 are not eligible for 2024, but may apply in 2025. Final eligibility is at the discretion of the ACVPA Board.

### **Does the project need to be ongoing?**

No. The project can be ongoing or recently completed. Projects that have paused due to a lack of resources can still apply.

### **Our project has been nominated before—can we reapply?**

Yes, but you will need to tell us how the project has changed since your last nomination. These changes need to have been in place for at least 12 months before you submit your nomination. You should differentiate the old and new project models, and outline how new components have added to the effectiveness of the project and enhanced crime prevention outcomes.

### **How are the award winners selected?**

All nominations are reviewed by the ACVPA Selection Board, which consists of representatives of each state and territory police service. With support from the AIC, the Board meets once a year to determine which of the nominated projects is most deserving of an award. There are separate award categories for projects led by police agencies and those led by other community or government organisations. Gold, silver and bronze awards are available in each category but not all levels of award are necessarily given out each year. The number of awards is at the discretion of the Board and will depend on the standard of nominations.

### **How does the Selection Board choose the winning projects?**

The Board's decisions take into account:

- the quality of the evidence presented to support the nomination
- the project's capacity or potential to prevent or reduce crime
- how project success is measured
- the ability for the project to be adapted for other geographic locations
- how sustainable project outcomes are
- how innovative the project is
- whether the project raises community awareness of crime and violence.

### **What should I include in the summary description of the project?**

The summary should clearly explain how the project operates. It should cover what crime issue the project is addressing, how it's addressing the issue, project outcomes and evidence of the project's success. As these are awards for the prevention or reduction of crime, you must clearly demonstrate the crime prevention outcomes.

### **Do we need a comprehensive independent evaluation?**

No. The evaluation could be a basic review of the project. When we say 'evaluation', we are looking for an objective review of the project which answers the question 'has the project been effective?' We need to know what has changed in the community as a result of the project, in order to judge its value.

### **Where do I send my completed ACVPA nomination?**

All nominations for the 2024 ACVPAs must be submitted online via [www.aic.gov.au/acvpa](http://www.aic.gov.au/acvpa)

If required, you may attach further details about your nomination. Attachments should be kept to a reasonable size and quality.

### **What if I can't upload my supporting documents?**

**When will the winners be announced?**

All winning nominations will be announced at an awards ceremony to be held at Parliament House, Canberra on 27 November 2024.

**What happens once a nomination has been successful in receiving an award?**

Successful applicants will be notified by email, and will need to return the requested form to the secretariat, to assist in the organisation and promotion in the lead up to the ceremony.

**Will unsuccessful applicants be notified?**

Yes. Unsuccessful applicants will be advised of the outcome of their nomination in writing after the award ceremony.
